## Pool Information

The Swimming Pool is one of the village's most used amenities over the summer months. In order for all of us to enjoy the pool safely, the South Carolina Department of Health and Environmental Control (DHEC) established rules. Violations of these rules can result in having your pool/clubhouse card turned off without warning. The village volunteers and staff are not babysitters or watchdogs, but they do have the responsibility of keeping WJV an enjoyable place for everyone. We ask that our residents please take a moment to read the pool rules on the sign at the pool and the pool regulations included in the Windjammer Village Rules and Regulations. (These can be found on our website or in the POA office.)

Please pay particular attention:

- Glass is not allowed at the pool. A recent incident where glass was broken at the pool resulted in clean-up fees of \$2,706.34.
- No diving at the pool.
- No running on the pool deck.
- No diaper dependent individuals are allowed in the pool.
- Please take the time to shower and rinse off pool toys before entering the pool to keep our pool maintenance costs down.
- Please keep the pool area clean.

Safety and cleanliness at the pool is everyone's responsibility!

### Fun Facts about our Pool:

- It contains 130,000 gallons of water and takes over 98 hours to fill up.
- An inch of rain adds 2,120 gallons of water to the pool.

## Dues Increase

Beginning July 1, the homeowners' dues will increase by \$4.00 resulting in costs of \$70 for improved lots and \$50 for unimproved lots. If you have automatic draft set-up, you do not need to do anything. If you use bill pay, be sure to increase the amount. If you have paid your dues for the year, please remit \$4.00 per month for July - December.
