## HAVE YOU REGISTERED FOR CodeRED?

In October of 2013, Horry County began utilizing the CodeRED® emergency notification system giving county officials the ability to deliver pre-recorded emergency telephone notification/information messages to targeted areas or the entire county at a rate of up to 60,000 calls per hour.

To date, the CodeRED® system for Horry County has over 111,000 phone numbers registered in the database. Citizens that have not yet signed up for the free notifications may log onto Horry County's website, click on "Departments" on the top menu. There are links to the CodeRED® system on the Fire Rescue, Public Information, Sherriff's Office, Police Department and Emergency Management pages.

All contact information provided remains private and will only be used for emergency notifications. Anyone without Internet access may call the Horry County Public Information Office at (843) 915-5390, Monday through Friday, 8 a.m. to 5 p.m. to give their information over the phone to be added to the CodeRED® system.

No one should automatically assume that his or her phone number is included. All businesses should register, as well as all individuals who have unlisted phone numbers, who have changed their phone number or address within the last year, and those who use a cellular phone as their primary home phone. Out of state property owners are also encouraged to sign up. Other CodeRED® features:
