## Architectural Committee

The Architectural Committee receives requests from WV residents regarding exterior property changes and improvements.

**September:** The committee approved six requests this month for the following: Repair driveway, two requests to replace roofing, replace skylights, replace front landing and steps, and repair siding. One request to install a metal roof is on hold. The BOD voted on one request to paint a house.

**October:** The committee approved 14 requests this month for the following: Stain deck, install retaining wall, install siding, install propane tank, replace driveway, install metal roof, roofing color change, extend start date for project, replace shutters, repaint home, touch up paint, replace deck railing, repair entrance to home, and replace roofing. The BOD voted on two requests to replace retaining wall and create parking space behind home. *Ken Mayo, Chair*

## GAC Committee

The GAC meeting has been permanently moved to the last Tuesday of the month; this month it will be held on 10/28 at 7:30 pm in the clubhouse. Contact me if you have any questions.

Last year, azaleas and other plantings were purchased for some vacant areas near the clubhouse. At the time, permanent irrigation was planned for the future, but that has yet to be installed. There may be an opportunity to place a permanent line during the new phase of asphalt paving for reduced cost. We would ask the maintenance committee to keep this in mind and investigate this opportunity. It would be a shame to waste both the plants and time of our volunteers.

Several GAC members attended the maintenance committee meeting this past month. There are real concerns over this committee's leadership, as the new chair never attended the original or rescheduled meeting. We would ask the BOD to consider recommending a co-chair to attend these meetings and participate more fully with the village volunteers.

We are beginning to contact residents on an informal level to ask them to bring their property in compliance with the unkempt standards passed on the July ballot. We will be presenting the board with recommendations regarding these properties at a future meeting.

The GAC is very concerned by the general state of affairs in our POA. There is a lack of professionalism, leadership, and accountability in our community; these problems are not shared with our neighboring communities and seem to uniquely affect WJV. This criticism is not intended as an indictment of any current volunteers or board members. It is intended to bring to light the failure of our POA's system of governance, a system that did not account for a future where the number of volunteer working hours was limited to the current levels.

The maintenance chair position illustrates this problem quite well; this volunteer position has the time requirements of a full time job. Few people would or should consider giving so much of their personal time and energy for such a thankless role. Too few residents are unreasonably being made responsible for the 399 lots and common property areas in WJV. There is little attention paid to long-term maintenance, a lack of planning and follow-through for major on-going projects, and limited accountability for everything. The GAC intends to brainstorm remedies and solutions for this problem over the coming months, and we invite all with any ideas to attend our meetings.
