## From the Office

The new visitors' call box is now installed. Please give visitors your 3 digit code, so they do not have to look up your name. We now have the capability to use long distance phone numbers and T-mobile numbers to allow access to the village. If you wish to allow guests via long distance or a T-Mobile number, please contact the POA Office with the number.

You will no longer hear, "Access Granted, Please Enter." When you wish to allow entry, hit 9 on your phone. You will hear a beep, but no further feedback is allowed with the new system. If you have questions, stop by, look at the new box and familiarize yourself with it.

## Notes from the Board

The board would like to remind village residents of the following:

- We would like to urge all residents to file a police incident report when they notice that their private property has been stolen or vandalized. Even if there is little hope for recovery of the item, a police incident report formally documents the crime and may be useful in the future.
- **The SC DMV has established rules for golf cart operation:**
  - Must be operated in daylight hours only
  - Operator must have a valid driver's license in his/her possession
  - May be driven only on a secondary highway or street within two miles of residence or place of business
  - Must be operated by owner(s), his/her agents or employees
  - Person selling a golf cart must immediately notify the Department of Motor Vehicles in writing, giving the name and address of the new owner together with the date of sale.
  - Golf cart registration must be carried when golf cart is operated.
- **Horry County ordinance mandates the use of house numbers.**
  - These ordinances specify, "Address numbers shall not be less than four inches in height and made of a durable and clearly visible material in a contrasting color from the building [...] the numbers shall be conspicuously placed near the main door of each building so that the number can be plainly seen from the street."

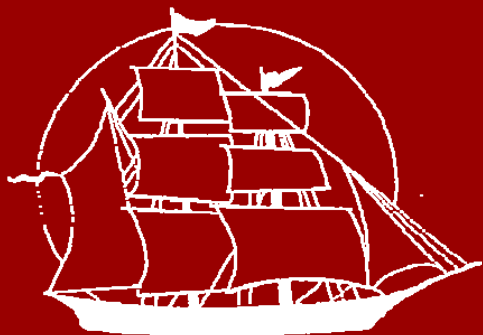
