BOARD

Reminder: Ballots are due by Wednesday, July 7th.
To be eligible to vote, POA dues, assessments and fines, including late payments, through the month of **June 2010** must be made by **Tuesday, July 6, 2010.**
Ballots with no return address will not count.

Barbara Tanner rescinded her resignation (which wasn't accepted by the Board). She wanted to keep the Village from changing all the records for just one month.

Inventory was taken of the compound. There are many spaces that have to be cleaned. There are many spaces that do not have names. We will be sending out letters to the violators who will be given 10 days to clean or put their name and lot # up, or in some cases both. If they don't comply, we will then have them towed. This has been an ongoing thing with some people. Everyone signed an agreement to keep the spaces cleaned when they registered for the compound.

We have been questioned about our rule on no diaper-dependent person allowed in the large pool. The following items are from DHEC rules (pp. 44 and 45):

e) In all cases of biological or chemical contamination of the pool water, the pool shall be immediately closed and the facility operator shall follow all current Department guidance in addressing the contamination before reopening of the pool. Biological contamination such as fecal, blood, or other body fluids shall be treated using guidance published by the Centers for Disease Control (CDC) on their "Healthy Swimming" web site...

16. Pool Temperatures

(a) Pool, spa, lazy river, or other pool type temperatures shall not exceed 104 degrees Fahrenheit.

Total budget for this fiscal year (ending 6/30/2010) is \$26,000. All insurance premiums are paid current. Total premiums paid to date amount to \$22,275.02. Less a return premium of \$1,114.00 from our Worker's Compensation insurance adjustment audit report.
